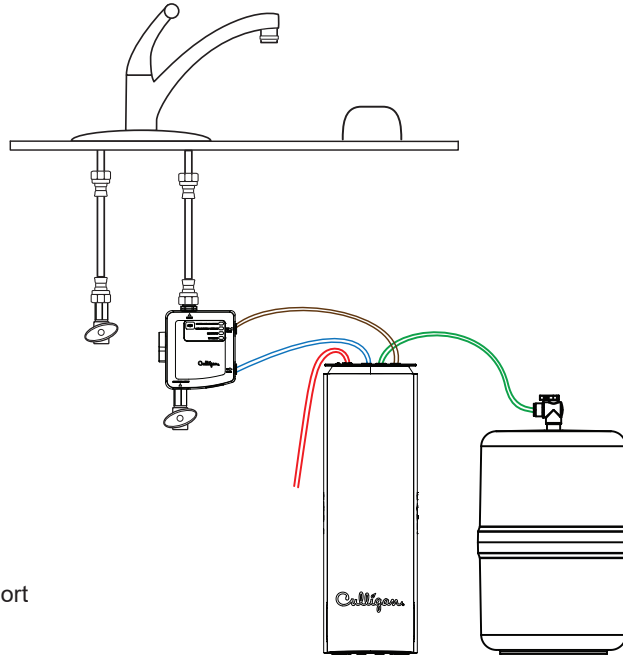

ClearLink™ PRO

The ClearLink™ PRO is a first-to-market wireless control system that allows you to get Culligan® filtered water from your main faucet. Installing an RO system used to require a dedicated faucet, which meant drilling a hole or losing a soap dispenser. Now you can use your existing faucet to wash vegetables with your sprayer, fill pots for cooking, or simply enjoy a glass of filtered water.

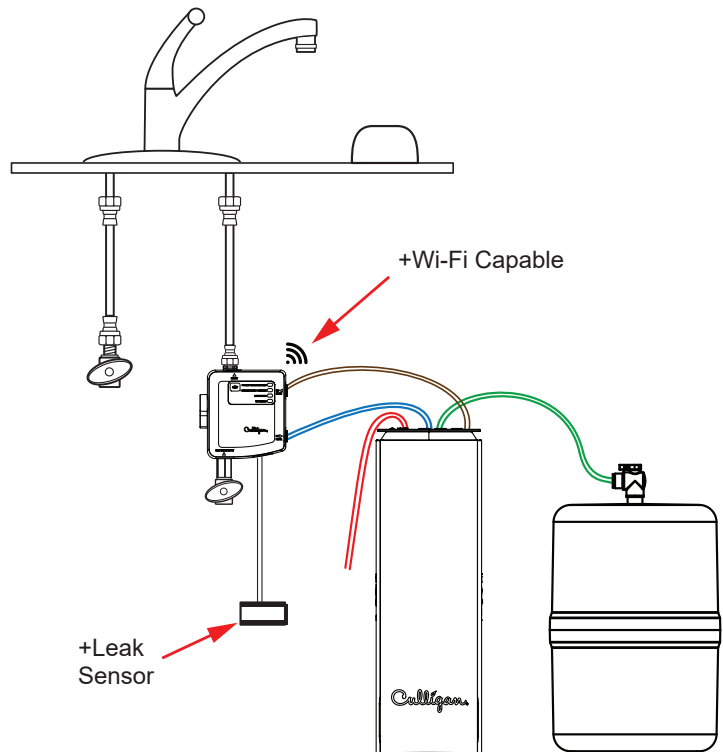
NOTE Illustrations are for overview purposes only, for RO installations an air gap and RO tank is needed.

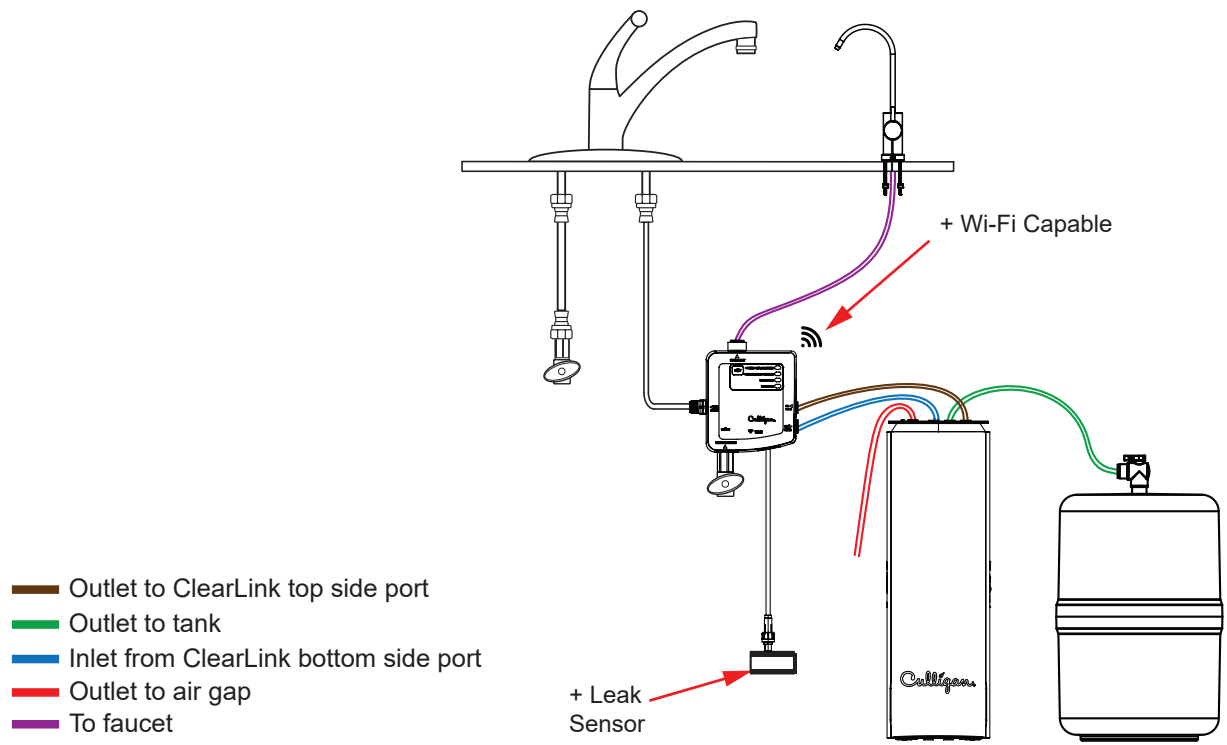

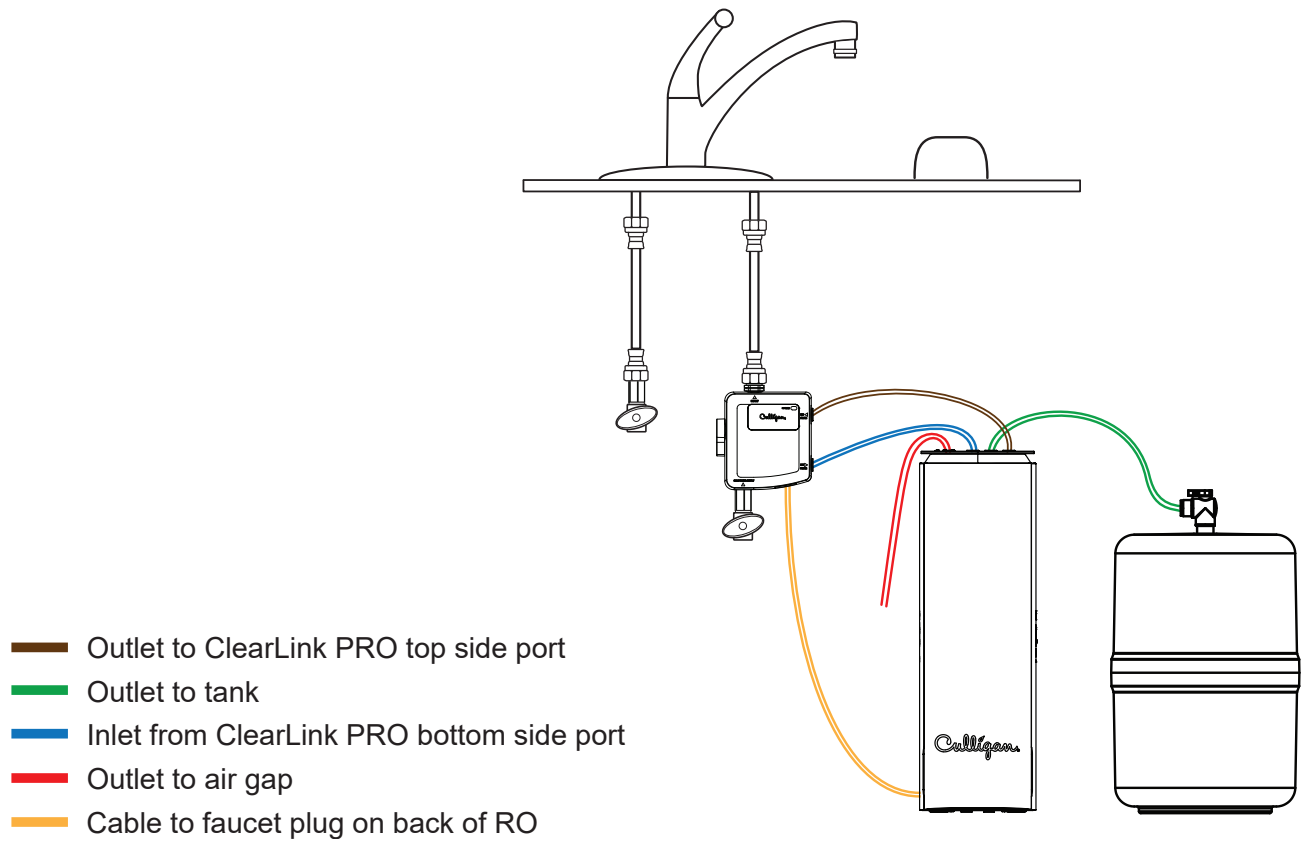
NOTE Separate connections for filtered and unfiltered water.

This Wi-Fi enabled product can be added to virtually any household drinking water installation and adds the ability to connect to the Culligan Connect App. Track water consumption, contaminants being removed, filter / membrane life and if a leak is detected from anywhere, using the convenience of an app.

The Aquasential® ClearLink™ PRO is specifically designed to work with our new Aquasential® Smart RO, the most efficient RO drinking water system available. This version of the ClearLink allows you to keep the great features of the ClearLink PRO all while being integrated directly into your Smart RO system, giving you more information at your fingertips.

Precautions



WARNING! Follow all precautions indicated in the manual provided with the Culligan water treatment system.

WARNING! For systems using a booster or distribution pump, the pressure of the treated water cannot exceed the pressure of the cold water supply.

WARNING! Reducing the Booster pump pressure below incoming pressure will allow the proper operation of the ClearLink.

WARNING! For cold water use only. Do not use on hot water line.



CAUTION! Control box must be protected against freezing temperatures, frost, snow, sleet and ice. Exposure to these can produce cracks and product failures.

CAUTION! The Filter/RO should be flushed before installing into the system to ensure the proper operation of the ClearLink.

CAUTION! This product has a limited service life. We recommend that a record be kept regarding the date of install and any other performed maintenance. Because of the product's limited service life and to prevent costly repairs or possible water damage, we strongly recommend that the control box be replaced every ten years.

- After prolonged periods of non-use (such as during a vacation) it is recommended that the system be flushed thoroughly. Let the filtered water run for 5-6 minutes at 1.6 gpm before using.
- The ClearLink estimates filter life based on flow and time. Changes in taste, odor, color and/or flow of the filtered water could indicate that the filter(s) should be replaced.
- Make certain that installation complies with all state and local laws and regulations.

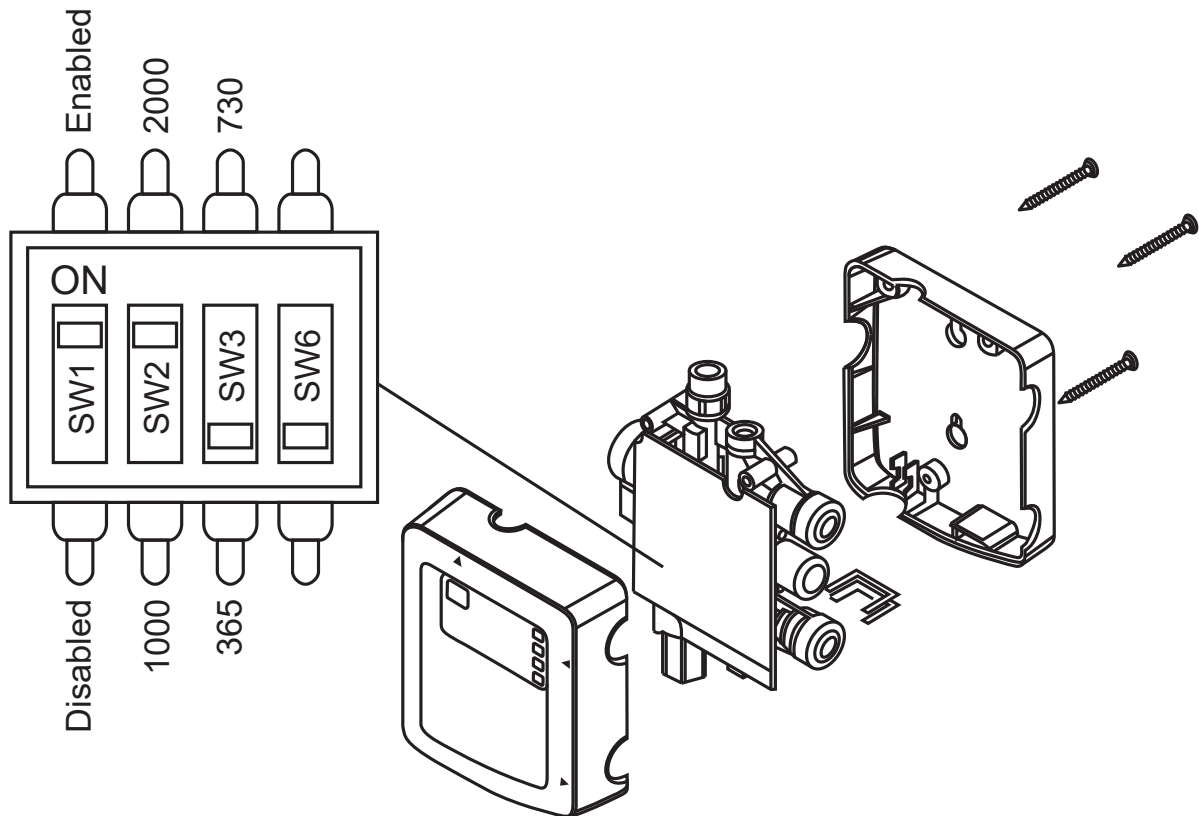
Setting Capacity and TDS Function (All Models)

NOTE This section does not apply to Aquasential ClearLink PRO

Find the dip switches on the front of the circuit board. SW2 and SW3 set the time and capacity for the filter reminder. Default settings for the dip switches are TDS ON, 1000 gallons and 365 days.

- SW1: Enables/Disables the TDS function (Enable only for RO systems). The system will measure the difference between the feed and product water to determine if the RO is working. If installing an RO system with a Mineral Boost cartridge, this feature may need to be disabled so that the alert indicator does not illuminate prematurely for RO membrane replacement.
- SW2: Filter capacity in gallons.
- SW3: Filter capacity in days.
- SW6: Used for production testing and should be left in the off position.

If dip switches are changed from the default positions, you must press and hold the RESET button to ensure filter capacity is counted correctly.



NOTE Set capacity and TDS function before starting installation.

NOTE To access the dip switches for setting capacity and TDS function, open the control box by removing the three screws in the rear cover.

NOTE No combination of SW2 and SW3 positions will disable either setting. The alarm and/or notification for filter replacement will always alert based on whichever capacity setting is reached first. Therefore, it is also not possible to force the system to only alert based on ONE setting.

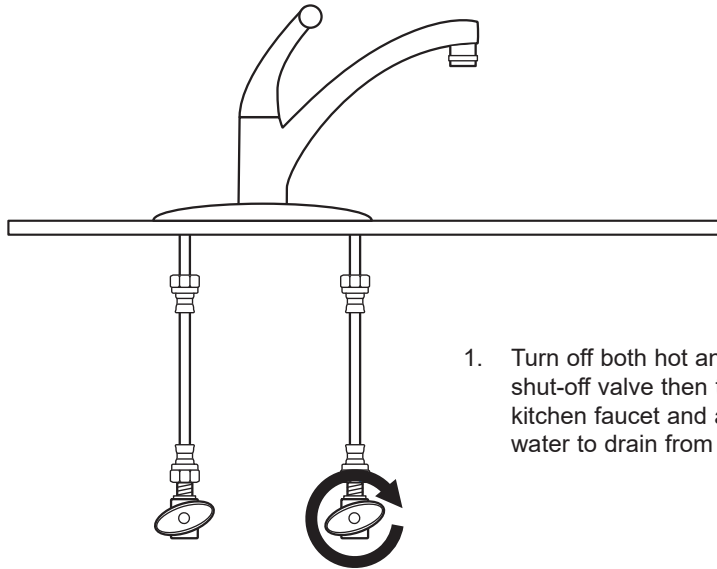
Installation (All Models)

NOTE If using an external flow switch, install the external flow switch before installing the ClearLink. See "[External Flow Switch for a Secondary Outlet](#)" on page 16 for instructions.

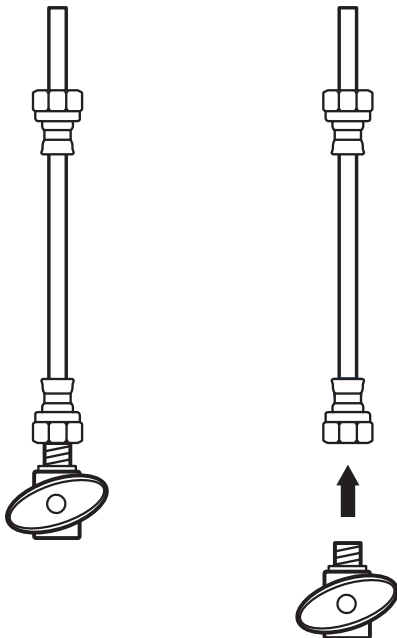
NOTE Refer to the manual provided with your filter/RO for installation instructions specific to that system.

NOTE Some installations may require adapters and fittings not included with the product. Review the manual and your installation before beginning.

NOTE Consult your local plumbing codes and install accordingly.

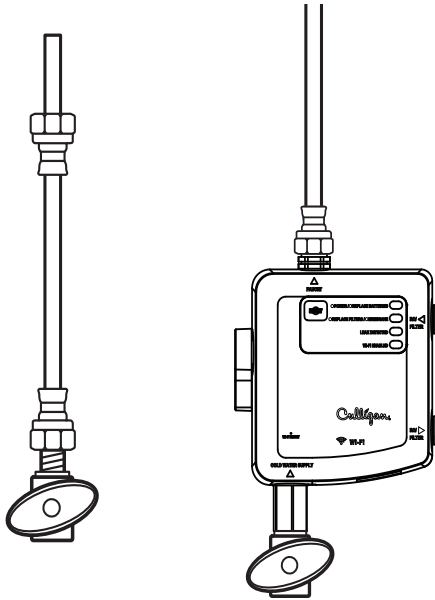


1. Turn off both hot and cold water shut-off valve then turn on the kitchen faucet and allow all water to drain from line.



2. Disconnect the cold water line from the cold water shut-off valve.

NOTE If rigid plumbing pipe (metal or plastic) is used, you may need to shorten the pipe using a hacksaw or pipe cutter to accommodate the control box.

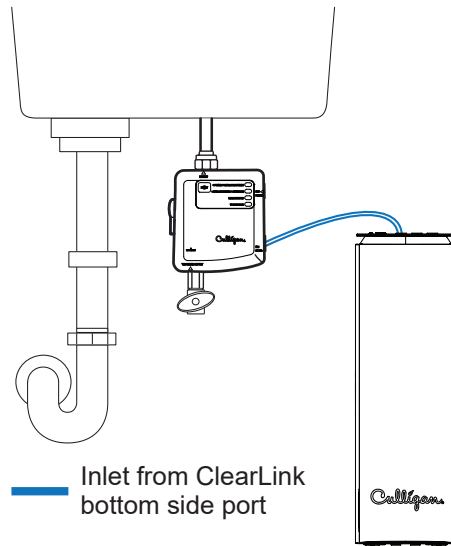


3. Connect the control box to the cold water shut-off valve and the water line to the Faucet as shown. Culligan recommends 1/2 - 3/4 additional turns past finger-tight.



CAUTION! The stationary hex nut on the outlet of the ClearLink should not be used to over-tighten the hose fitting.

4. Connect the inlet on the RO/Filter system to the port marked "RO/Filter ▶." Wet the end of the plastic tubing with water and push it into the quick connect fitting adapter approximately 5/8" until it stops.



NOTE The control box must be in a vertical position.

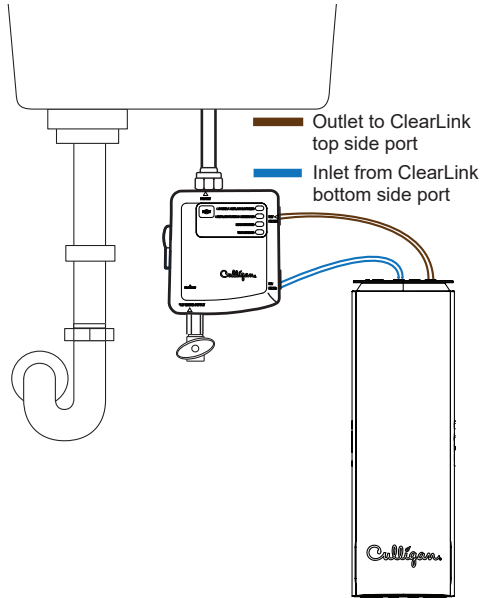
NOTE If space does not allow for mounting the control box onto the valve, it can be mounted on a wall and connected using flexible lines. (purchased separately).

NOTE Flare fittings used on cut-to-fit PEX line prevent the connecting nut from being threaded on more than 1-2 turns. Therefore, it is recommended that the MS031611 adapter listed in the "Installation Fittings and Replacement Parts List" section be used. The flare fitting of the PEX line should be cut off and the tubing inserted directly into the push-to-connect end of the MS031611 adapter.

NOTE All filters and RO membranes should be flushed before connecting any ClearLink device to the filtration/RO system.

NOTE The port marked "RO/Filter" is plugged for remote system installations (Water supply is not the same as the sink such as basement installations). This port is normally plugged when installing the filtration/RO system in a location other than the kitchen cabinet.

NOTE Use the supplied adapter if your system uses a 1/4" tube.



5. Connect the product water outlet on the RO/Filter system to the port marked "RO/Filter ►." Wet the end of the plastic tubing with water and push it into the quick connect fitting adapter until it stops.

NOTE This is the line that would normally go to your dedicated faucet.

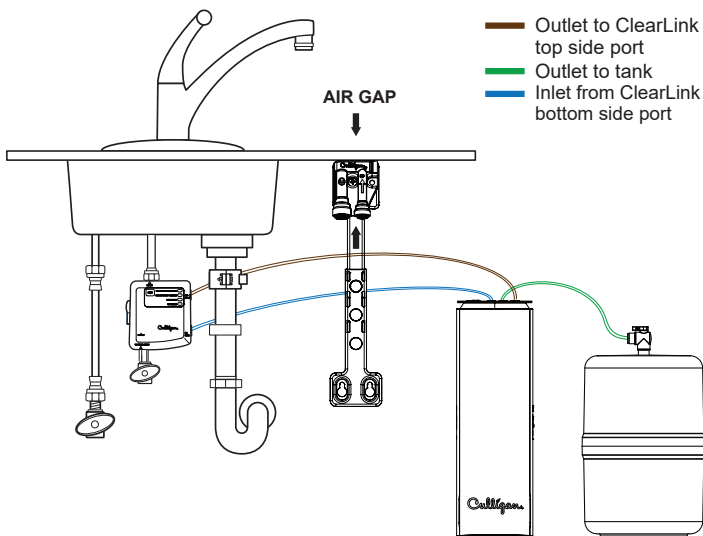
NOTE Connect the tank and/or post filter in this line if required for your filter/RO system.

NOTE Steps 6 through 8 are only for RO installations using an air gap.

NOTE If your filtration system is not an RO, skip to System Startup.

NOTE Install the drain connection to the drain plumbing according to the manual provided with your RO system.

NOTE Check and adhere to local plumbing codes for Air Gap installation.



6. Mount the air gap device as near to counter top as possible and in a vertical orientation.

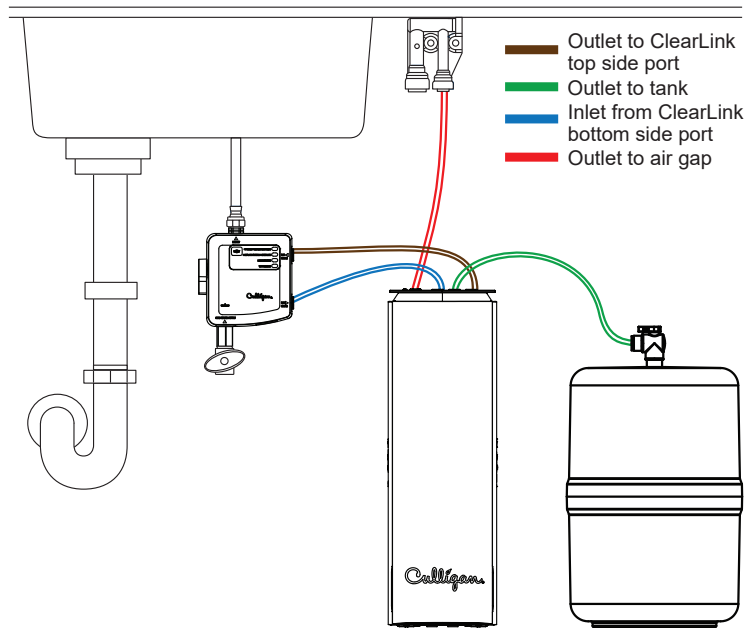
- 6a. The provided installation bracket can be used in order to assist in mounting the air gap as high as possible.

To use: Attach the air gap to the bracket using a single screw. Raise the assembly as high as possible and secure to the cabinet using the bracket's lower mounting points.

WARNING! Install the air gap as high as possible using air gap installation bracket.

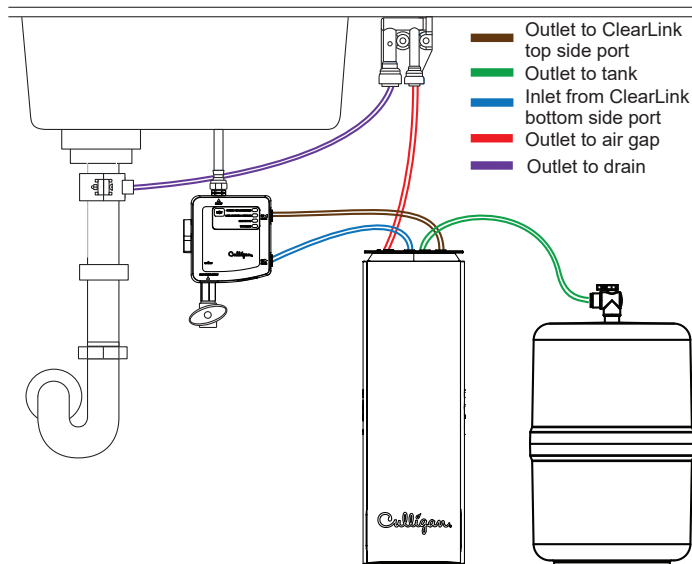


WARNING! Failure to mount the air gap device vertically will cause it to leak water.



7. Connect the drain line coming from the RO system to the 1/4" connection of the air gap device.

NOTE Drain line adapters are available through Culligan Marketplace that can be used when considering the best drain line connection.



8. Connect the 3/8" fitting of the air gap device to the connection on the drain plumbing.

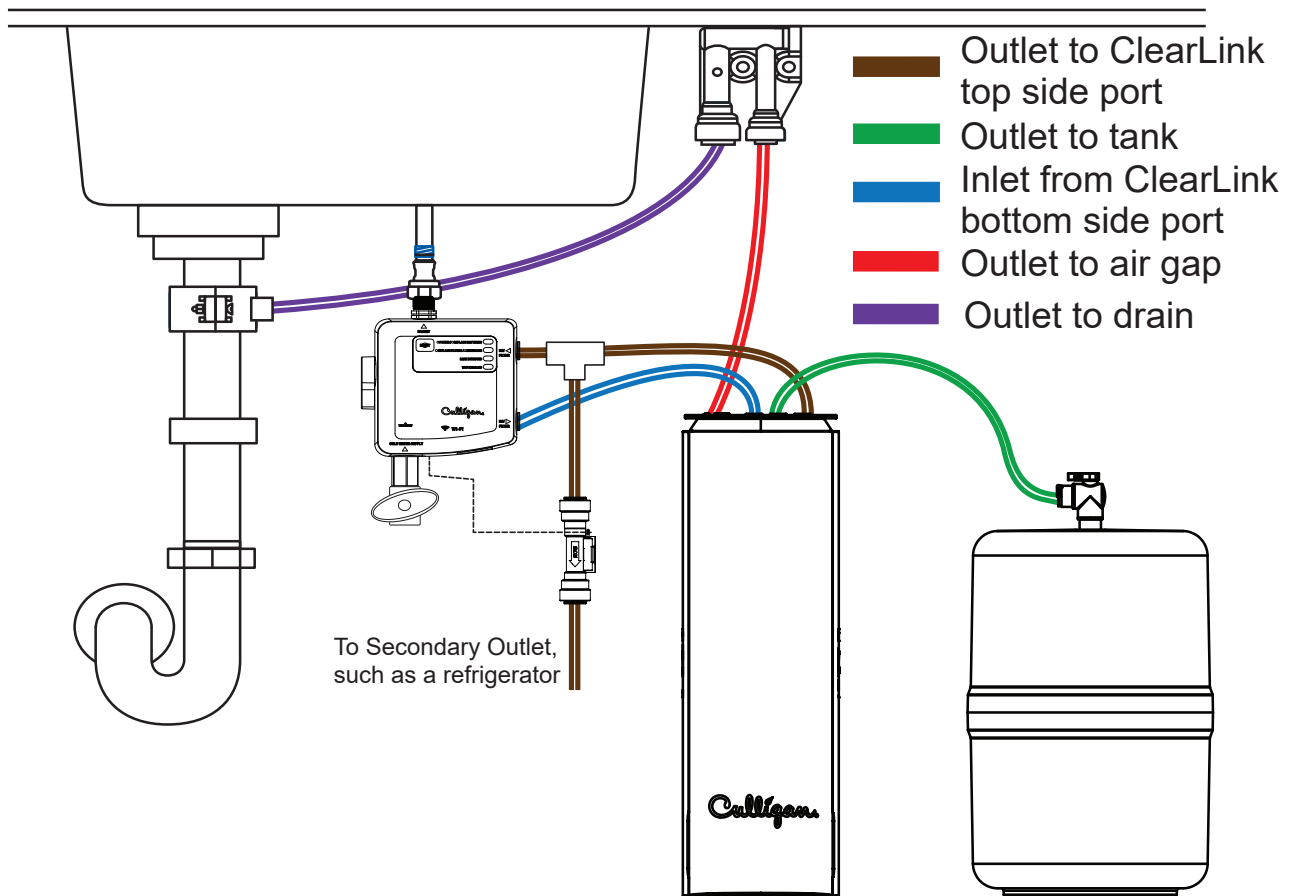
NOTE If the customer has a garbage disposal, connect the RO drain line coming from the air gap to the "auxiliary" port (removable plug where a dishwasher drain is typically hooked up) rather than downstream of the disposal. The high flow rate from a disposal sucking water from a clogged sink will send water up and out of the air gap.

External Flow Switch for a Secondary Outlet

For use with ClearLink Connect and as an optional accessory on the Drinking Water Connect.
Not available for use with ClearLink PRO or the Aquasential ClearLink PRO.

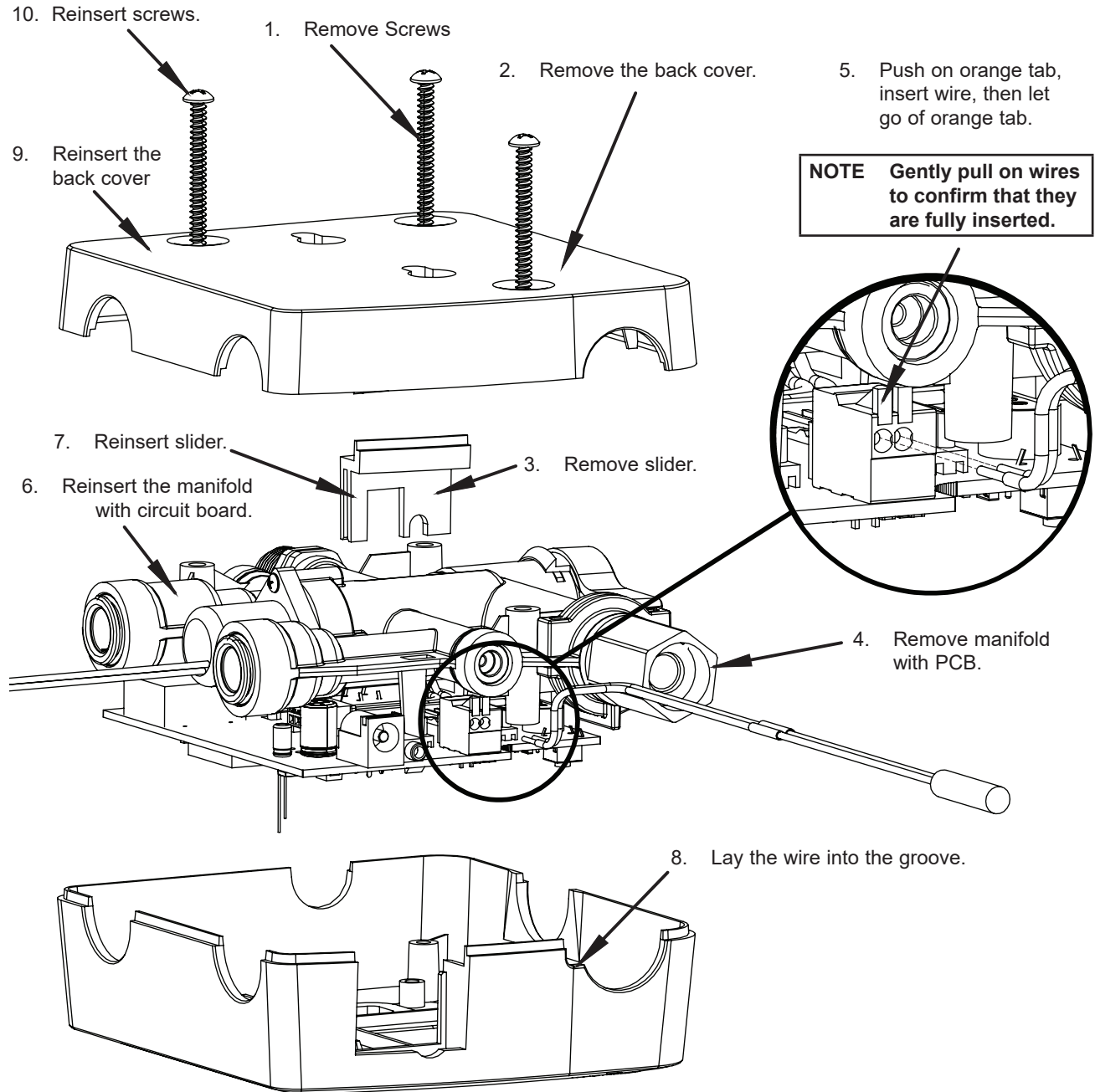

- NOTE** External flow switch must be installed after the post filter.
- NOTE** If the inlet of the refrigerator (or similar) requires 1/4" tubing, the reducing stem should be installed as close to the refrigerator as possible to reduce the pressure drop caused by smaller diameter tubing.
- NOTE** External flow switch is rated to operate between 0.25GPM and 1.32GPM.



Flow Switch Wiring

NOTE The standard length of the flow switch wire is 3'.
If needed, a 40' wire extension is available separately.



Flow Switch 40' Wire Extension Kit (if applicable)

- Using wire strippers, strip a 1/4" of insulation from the wire.

NOTE Stripping too much of the wire can cause the wires to fray, which can cause the unit to malfunction over time. Stripping too little of the wire can prevent the ends from being able to have proper contact with the connector on the PCB.

- Connect flow switch wires to the extension using the supplied crimp connectors.

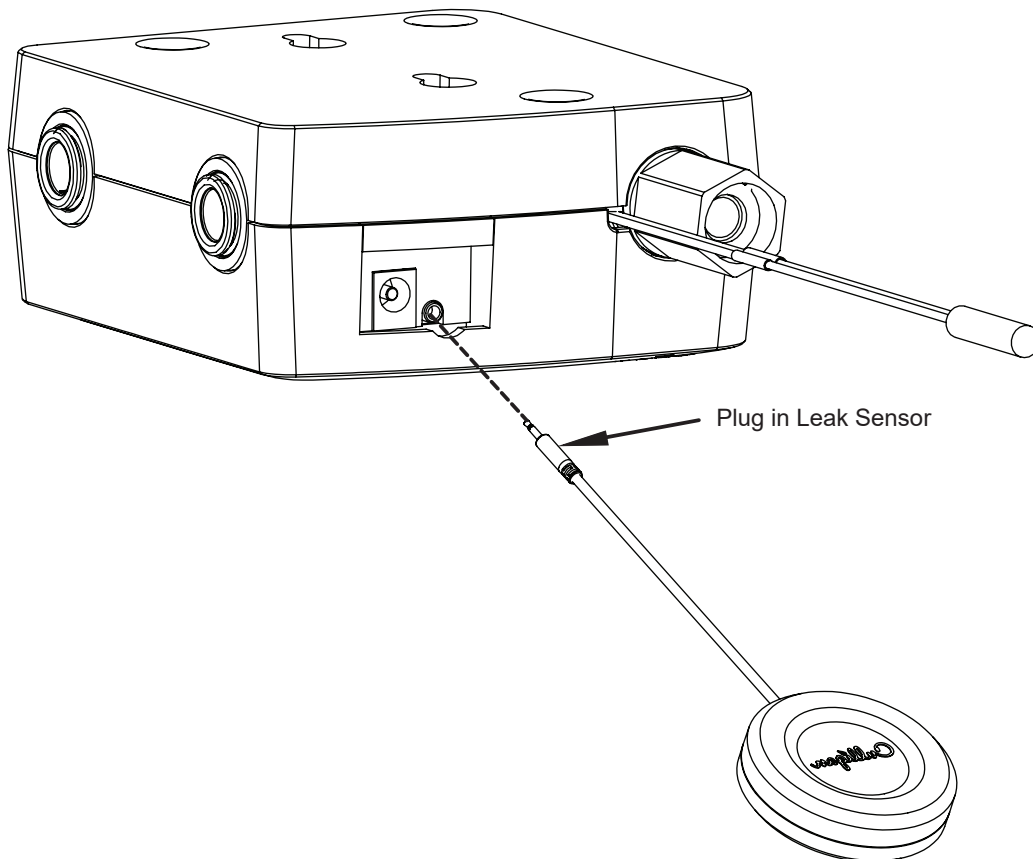


- Insert wires into the connector on the PCB, see "[Leak Sensor Installation](#)".

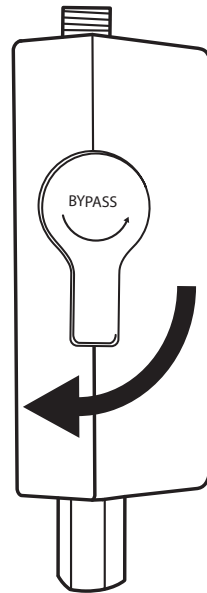
- Cut wire to required length.

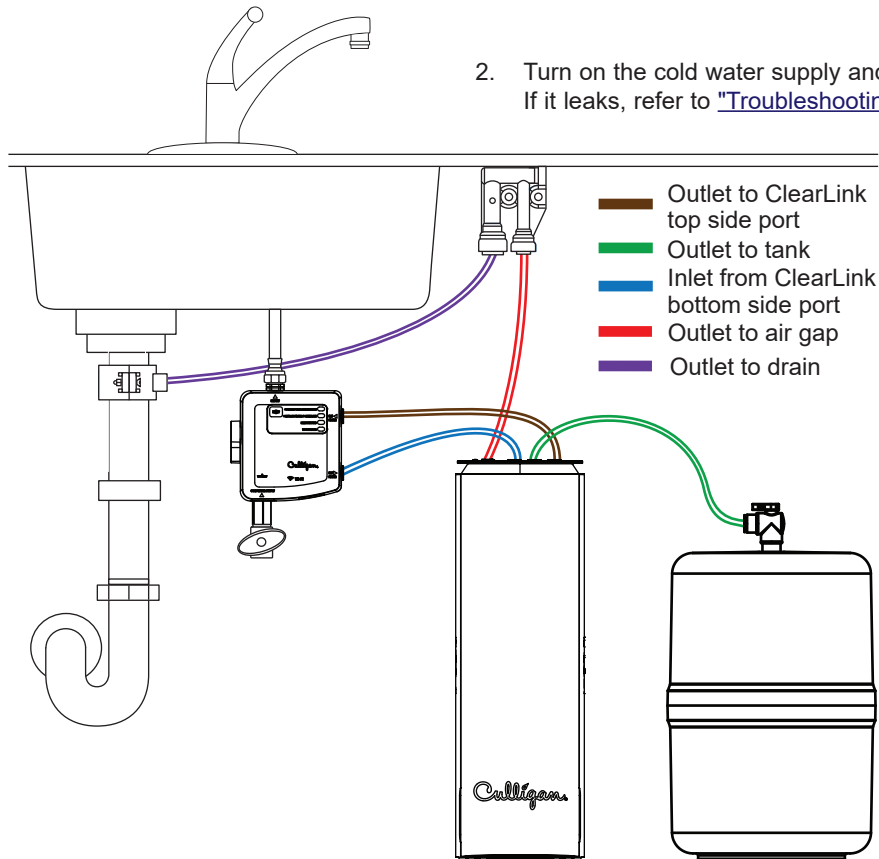
System Startup



1. Confirm that the bypass valve is in the closed position (pointed down).

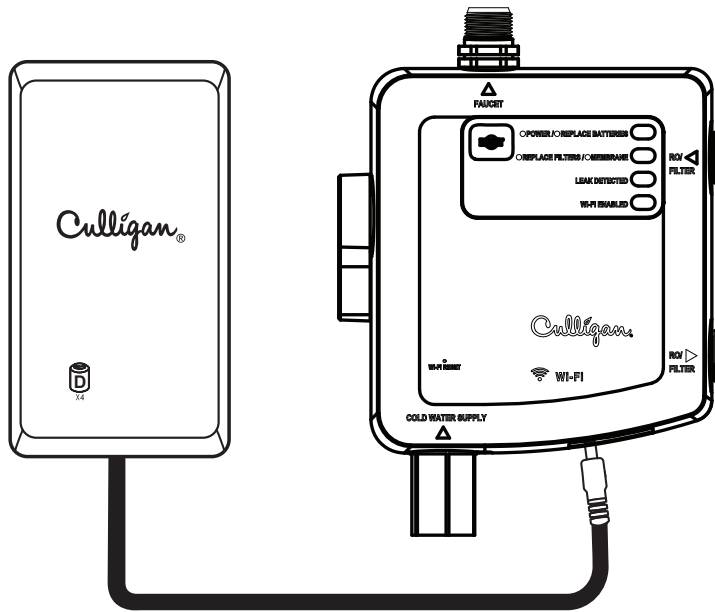
NOTE When in the open position, the bypass valve simply allows incoming water to flow straight to the outlet without having to pass through the solenoid junction. When the bypass valve is open, it is possible for treated water to mix with the unfiltered water depending on the supply pressure. See section labeled "Flow Path Diagrams" for further understanding.

2. Turn on the cold water supply and check for leaks. If it leaks, refer to ["Troubleshooting" on page 28](#).

3. Install four D batteries (not included) into the battery box and plug into the jack on the bottom of the control box.

Figure 3. Battery Box

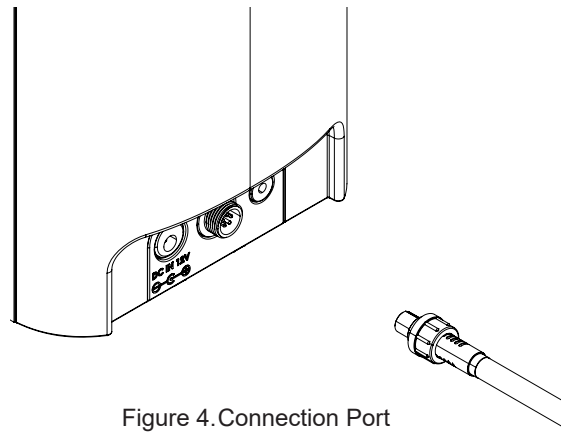
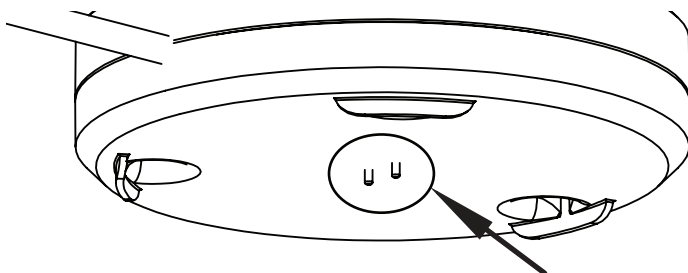
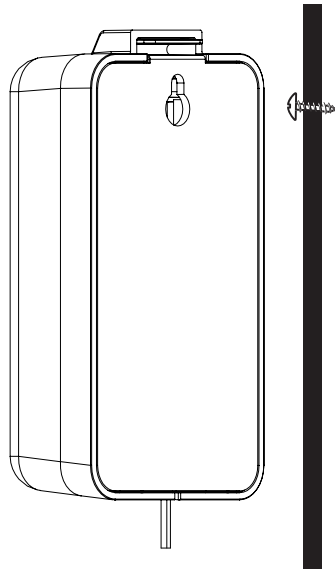


Figure 4. Connection Port



4. Place a damp paper towel to the pins. This should cause the leak sensor light on the control box (page 19) to flash, the unit to beep and the Culligan Connect App (if setup) to notify the user of the error.
5. Dry pins and place at the lowest point in the cabinet or under the ClearLink Control Box.

6. Use the provided screw to hang the battery box on the side of the cabinet.

Figure 6. Hang Battery Box on Side of Cabinet

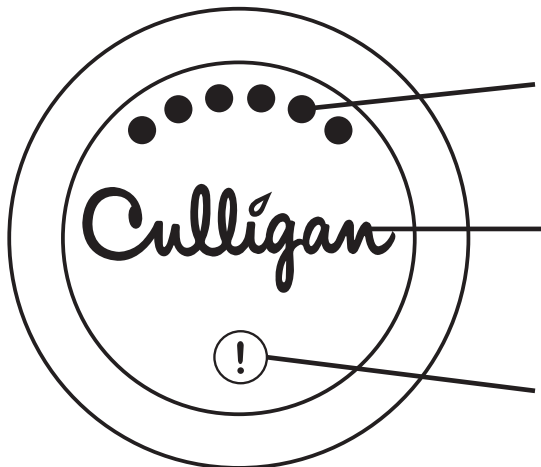


7. Install two AAA batteries (not included) into the remote button.
- 7a. Burp air after assembling battery cover. To relieve air, lift back one edge of the base, press center of rubber down, release edge.
8. Turn on the faucet to full cold and push the button to activate the system.

Button Display Guide

ClearLink Button Display



Filter Capacity Lights: Shows from 1-6 lights depending on filter capacity remaining, 6 lights => 80% and 1 light =<10%.

Culligan Logo: Flashes when treated water is not available from the faucet. Stays solid while treated water is being dispensed from the faucet.

Alert Indicator: Illuminates when the control box batteries need replacing, filters need replacing, membrane needs replacing or if leak is detected on connected versions.

NOTE All filters and RO membranes should be flushed before connecting any ClearLink device to the filtration/RO system.

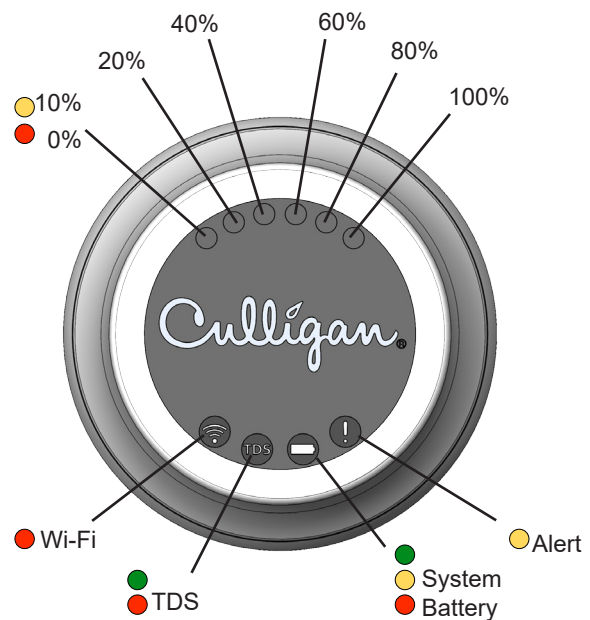
NOTE The blue capacity lights should appear if the button and control box are communicating.

NOTE The button can be turned off with a second push or by turning off the faucet.

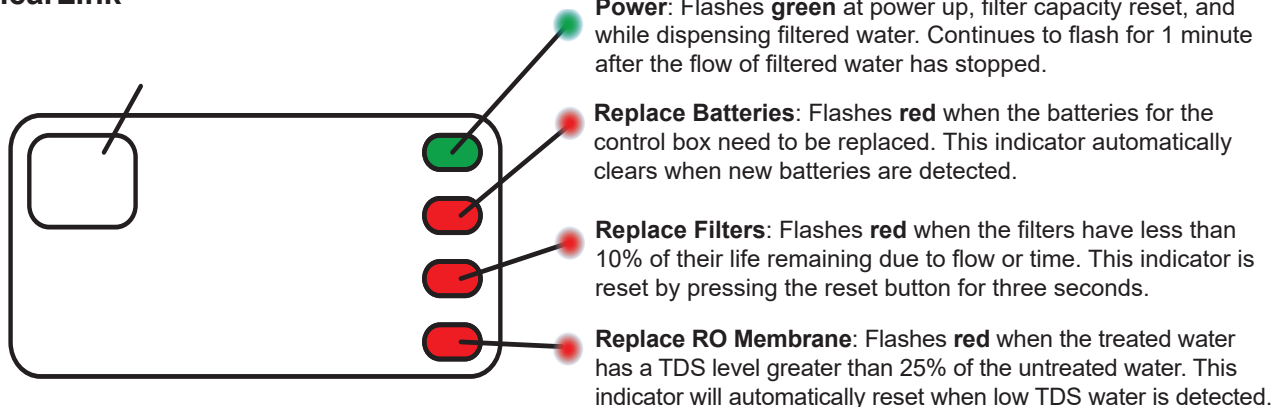

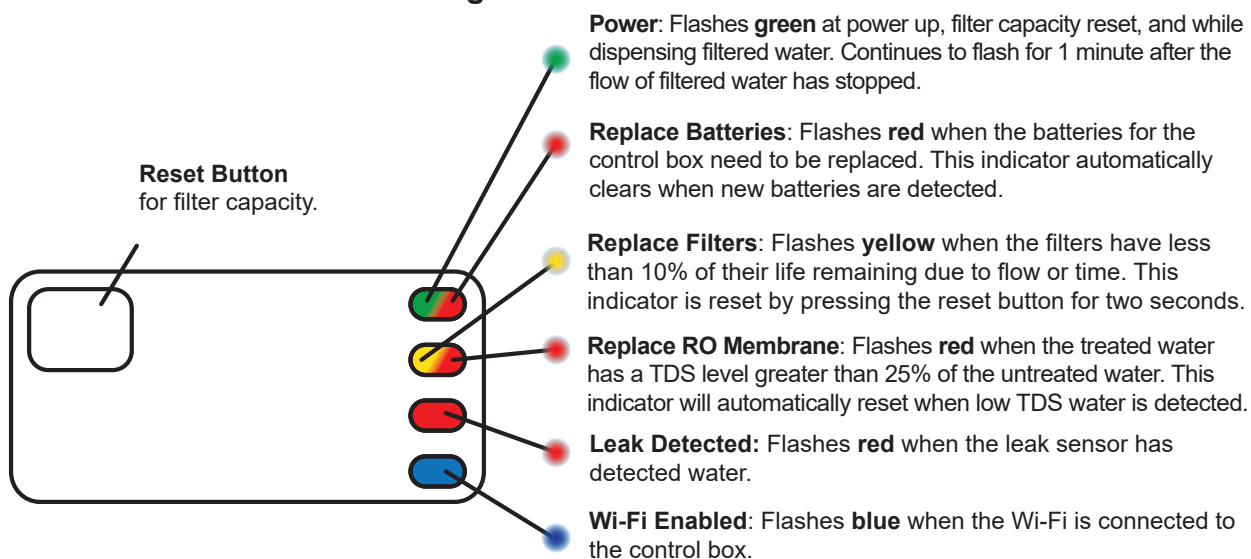

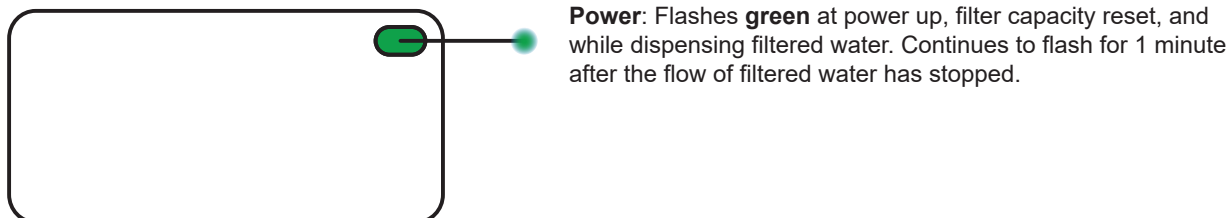

NOTE This section is only applicable to the ClearLink Connect and Drinking Water Connect

Pair to Android

1. Download and install “Culligan Connect” app from the Google Play Store to the customer’s smart device.
2. Log in if the customer has an existing Culligan Connect app or create a new account if they do not.
3. Verify through the email on the customer's tablet/phone.
4. Once logged in, tap “add system” and follow the prompts.

NOTE You will have a 24 hour window to confirm the account.

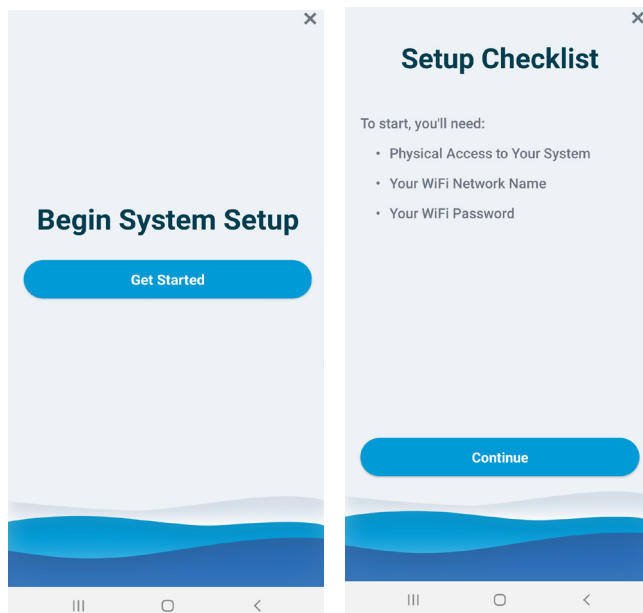
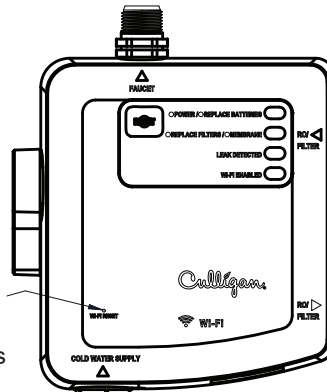
Wi-Fi Reset Button:

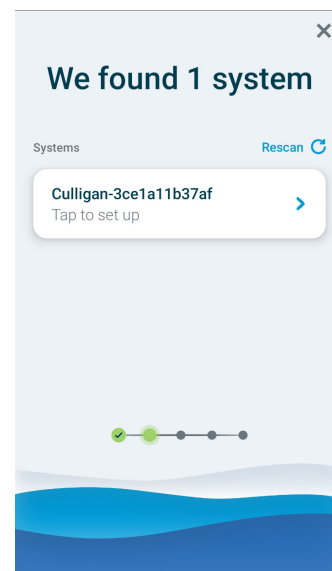

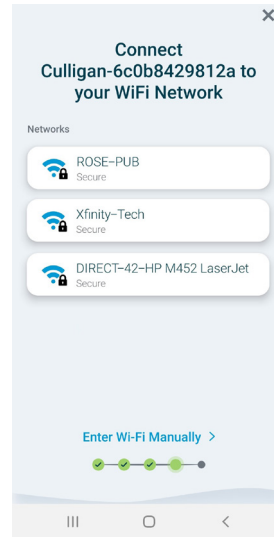

Pair to iPhone or iPad

1. Go to Apple's App Store to download and install "Culligan Connect" app to the customer's smart device.
2. Go to device settings and connect to their local Wi-Fi network.
3. Launch Culligan Connect App.
4. Create a new account by selecting "Create an account".
A link will be emailed to them that must be clicked via their device to finalize setup. Once finalized, log in.

NOTE You will have a 24 hour window to confirm the account.

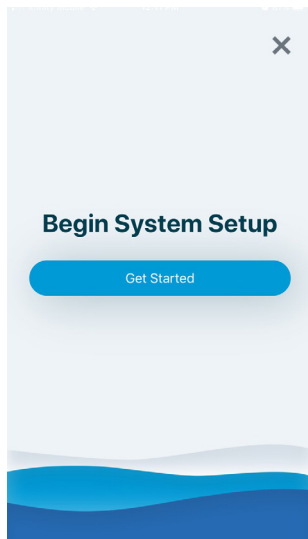
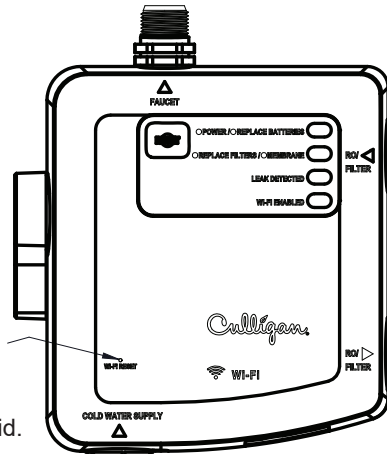

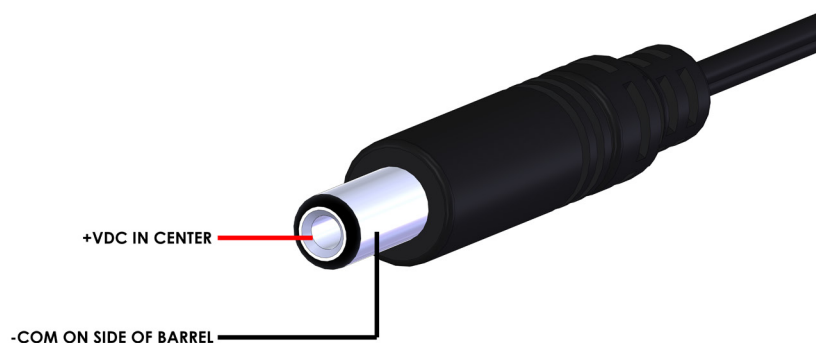
Troubleshooting

Best Practices for Installations

Follow these suggestions as you install and service the ClearLink models for the best results,

- Ensure the button is burped following battery cover assembly.
- To make battery cover installation and removal easier, apply Dow Corning 200 lubricant as needed.
- Power
 - If possible, use the optional 01029455 AC Adapter instead of batteries for the installation. Note that this adapter is only for use with the ClearLink PRO, ClearLink Connect and Drinking Water Connect.
 - Using name brand high-quality alkaline batteries can greatly extend battery life and product functionality.
 - On "ClearLink Connect versions" consider using the power save mode as this will send an update once every 24 hours.
- Test unit operation, re-installation, to ensure you will not have any issues with space constraints or communication between the button and manifold
- Install the air gap using straight, short-as-possible runs of the gravity drain tubing. Locate the drain connection away from the disposal to reduce the likelihood of leaks or blockages.
- The control box needs to be installed as vertically plumb as possible for the solenoid to work properly
- If you have height / space constraints under the sink you can always install on the side cabinet using braided hoses or tubing with the installation adapters
- Use braided flex hoses to make your connections. Avoid using compression nuts and ferrules at the outlet fitting. When needed, use the push fitting adapter for PEX or LLDPE Polyethylene Tubing
- Use care when starting the threads on the plastic outlet fitting to avoid cross-threading or damaging the threads. Do not overtighten.
- Do not rinse any filter, including the post carbon filter, through the control box as it could cause clogging issues in the solenoid or check valve. Pre-rinse all cartridges first
- Flushing or rinsing the cold water line to the sink could help remove debris loosened during the installation and avoid it getting trapped in the solenoid which could affect its operation
- The low voltage limit for the control box batteries is 4.75VDC; if the system detects a voltage at or below this level the low voltage alerts will activate. During service, the current voltage level of the batteries can be checked using a Voltmeter or multimeter by unplugging the battery box from the ClearLink control box and measuring the voltage at the barrel connector. The center of the connector is +VDC and the outer surface is the -VDC terminal. See "Figure 8. Battery Voltage Measurement" for reference.

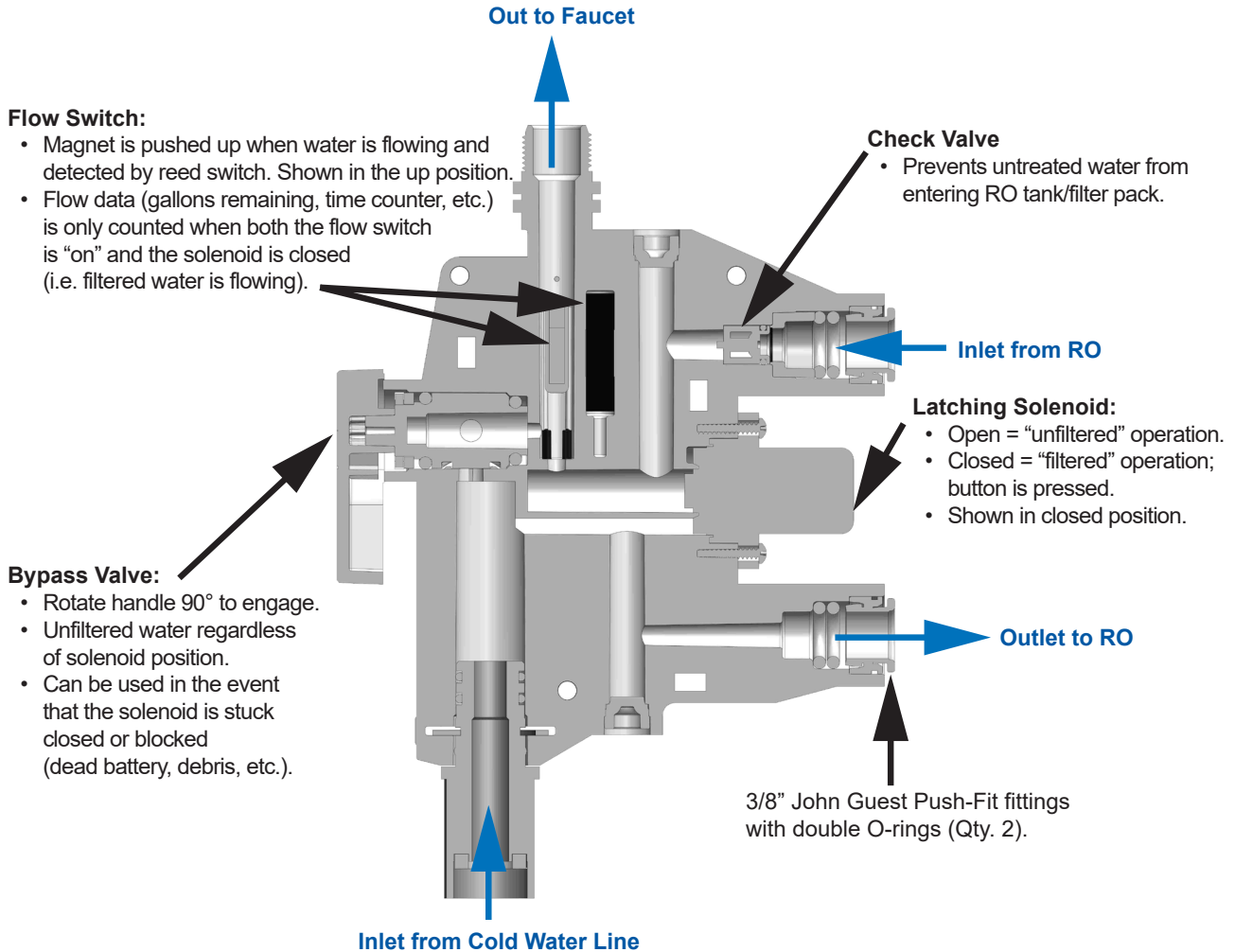
Problem or Symptom	Cause	Solution
Button is difficult to press	Air is trapped in the button after assembling the cover.	Burp air after assembling battery cover. To relieve air, lift back one edge of the base, press center of rubber down, release edge.
Leaks at filter/RO Inlet or outlet connection	A rolled o-ring can block the tube from fully inserting	Use a small screw driver to reseal the O-ring and then confirm that the end of the tubing has a clean, square cut.
Low filtered water flow/ system returns to unfiltered flow automatically	Low flow rate	A system operating under low flow rates may not activate the internal flow switch. Refer to your system manual to troubleshoot a low flow condition.
No change in flow when button is pressed	Bypass knob is diverting water	Confirm that the bypass valve is in the down/closed position
	Button is not communicating with control box	Check to ensure that both the button & control box batteries are installed correctly. Replace any batteries if low power assumed.
	Solenoid valve is stuck and cannot divert water	Test the solenoid to ensure it is working, this can be done by flowing your main water, pushing the ClearLink button and closely listening for an audible click or feeling the solenoid divert by holding the control box. (This can also be done with the unit removed by flipping the control box upside down to simulate flow). If solenoid is bad refer to "Solenoid Replacement Procedure" in manual and replace Remove the solenoid and diaphragm (refer to "Solenoid Replacement Procedure" in manual) to clean out debris.
Button communication is intermittent	Button is not communicating with control box	Check to ensure that both the button & control box batteries are installed correctly. Replace any batteries if low power assumed.
	Weak signal	Different materials may block the wireless signal more than others. Try moving the button to an area on the counter that is closer to the under-sink control box.
High TDS in product water	Debris in solenoid or outlet check valve	Remove the solenoid and diaphragm (refer to "Solenoid Replacement Procedure" in manual) to clean out debris. (Best practice: Ensure all cartridges, including in-line bullet are pre-rinsed prior to installation)
Button falls into water	Users try to operate the button to see if it still works while it still has a wet board / batteries	DO NOT TRY TO OPERATE the button. Remove the two AAA batteries and place the button in a bowl and cover with rice for at least 24 hours to assist in drying it out. Do not use until completely dry.
Water leaking from Air Gap	Air gap is installed incorrectly	Create as short as possible run of the gravity drain tubing with no angles to the drain connection. Make sure your drain is located away from the disposal to reduce the likelihood of leaks or blockage.
Power light on Aquasential ClearLink PRO control box is not on	No power to Aquasential ClearLink PRO control box	Ensure AQ Smart is powered on and rechargeable battery has sufficient charge

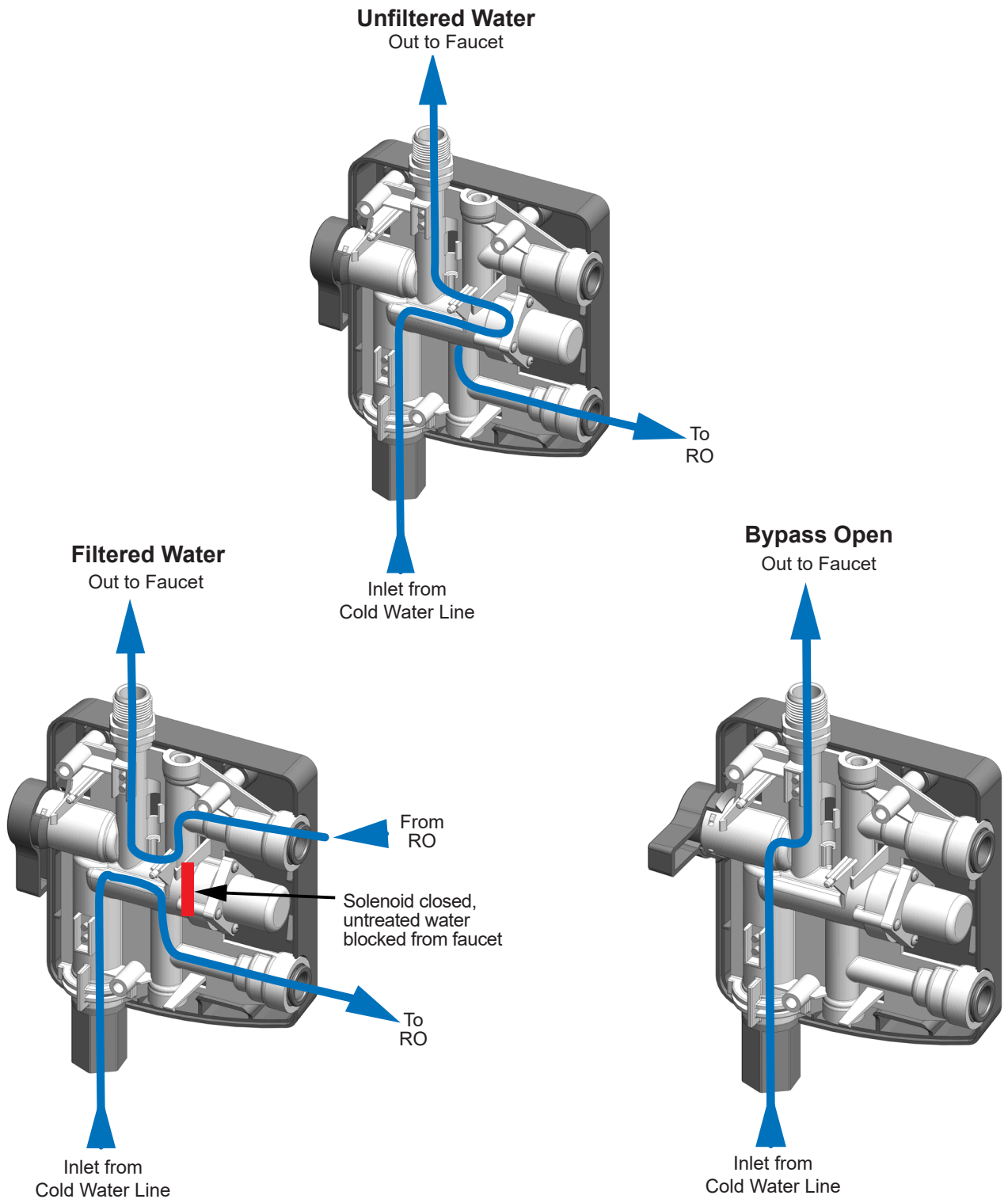

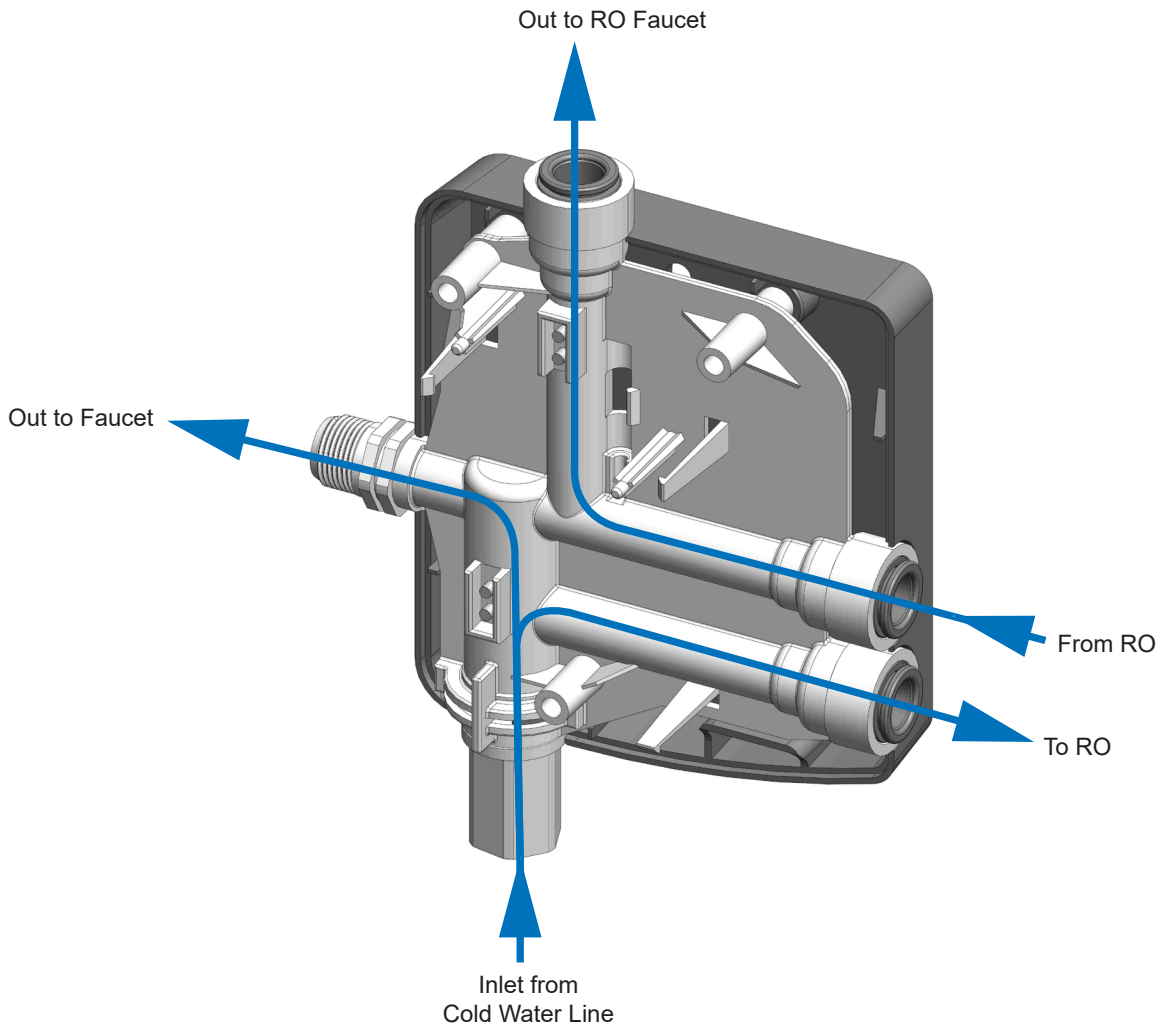
1. Take off the cover by removing the three rear screws.

ClearLink PRO, Aquasential ClearLink PRO, and ClearLink Connect

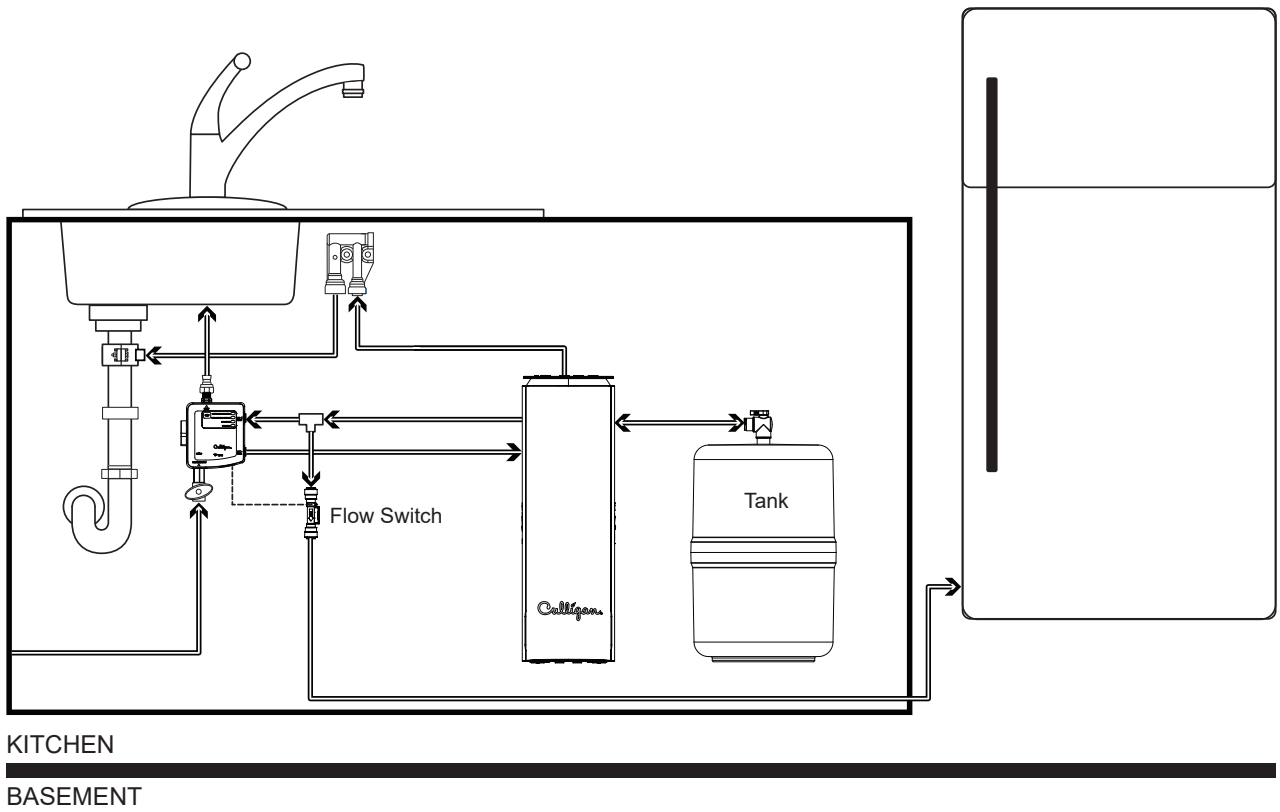

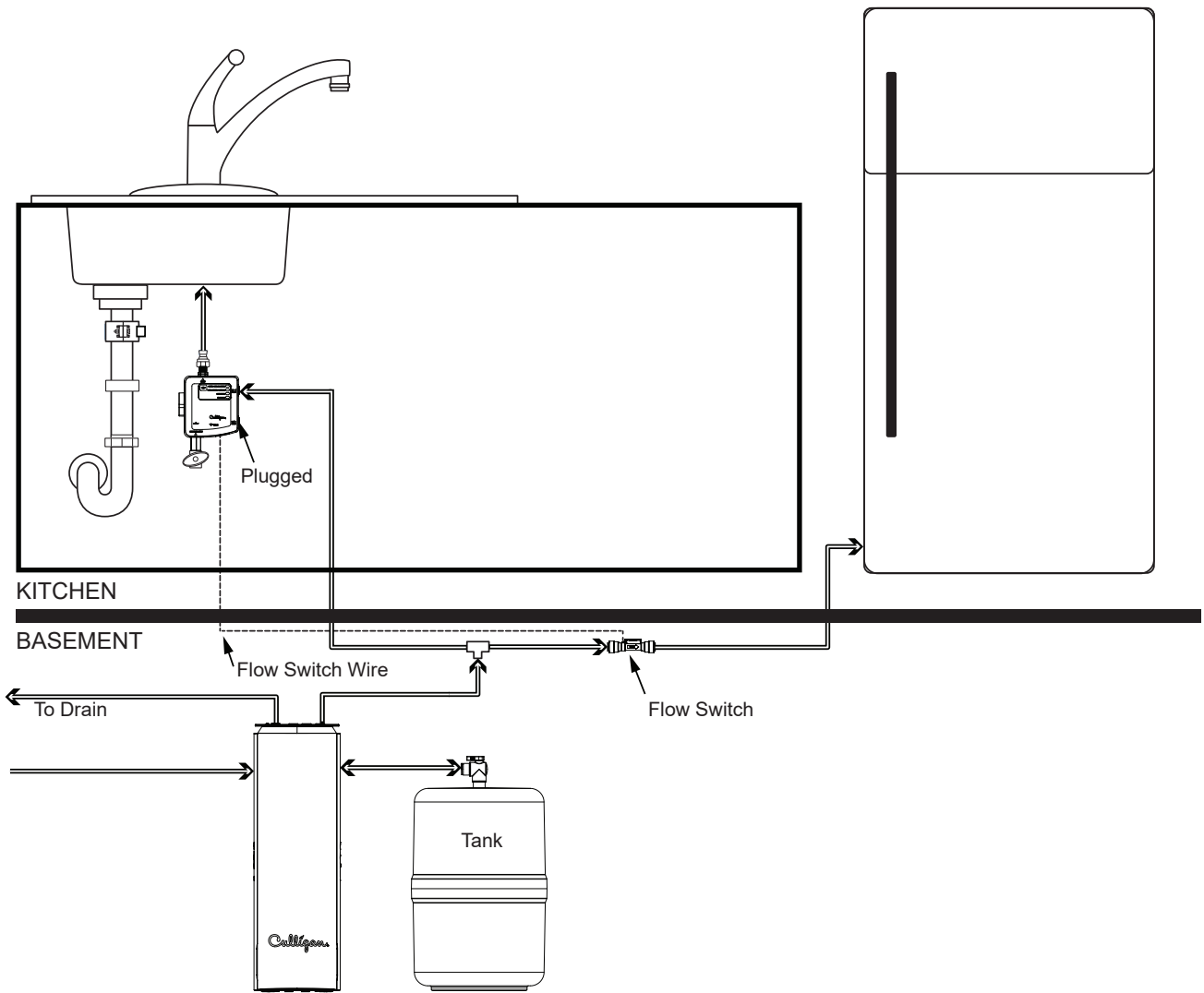

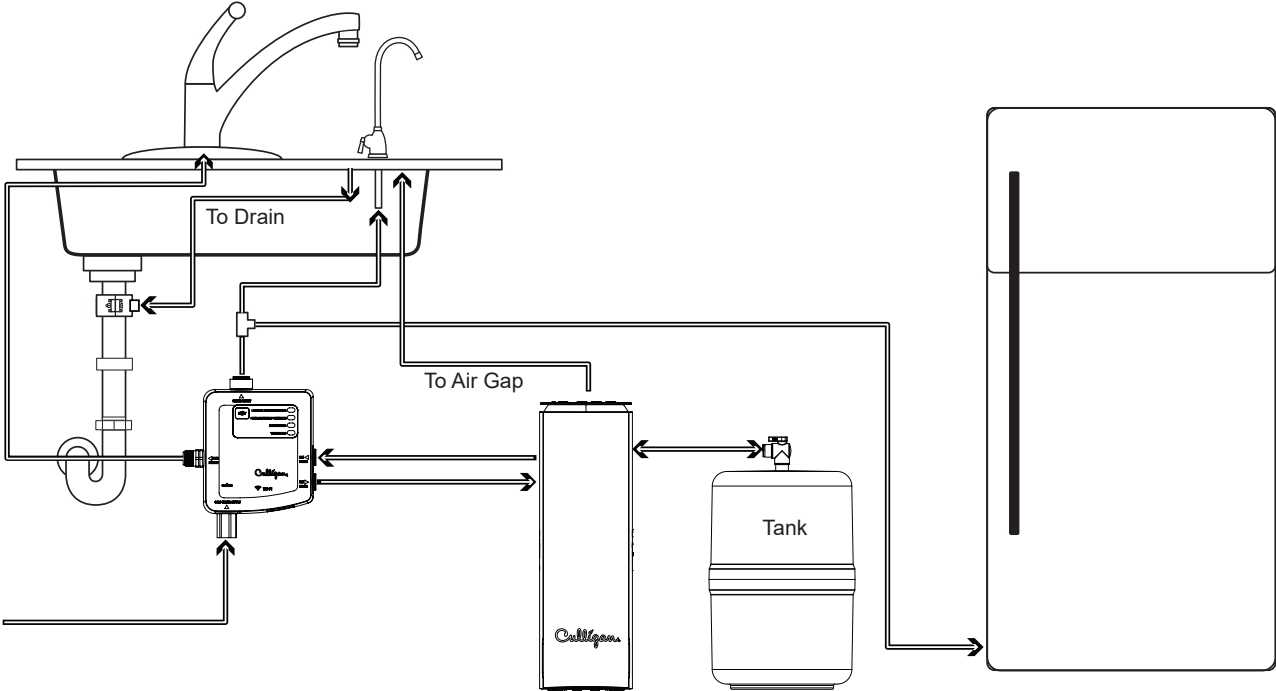
ClearLink Connect: Under Sink Install with Secondary Line



ClearLink Connect: Remote Install with Secondary Line



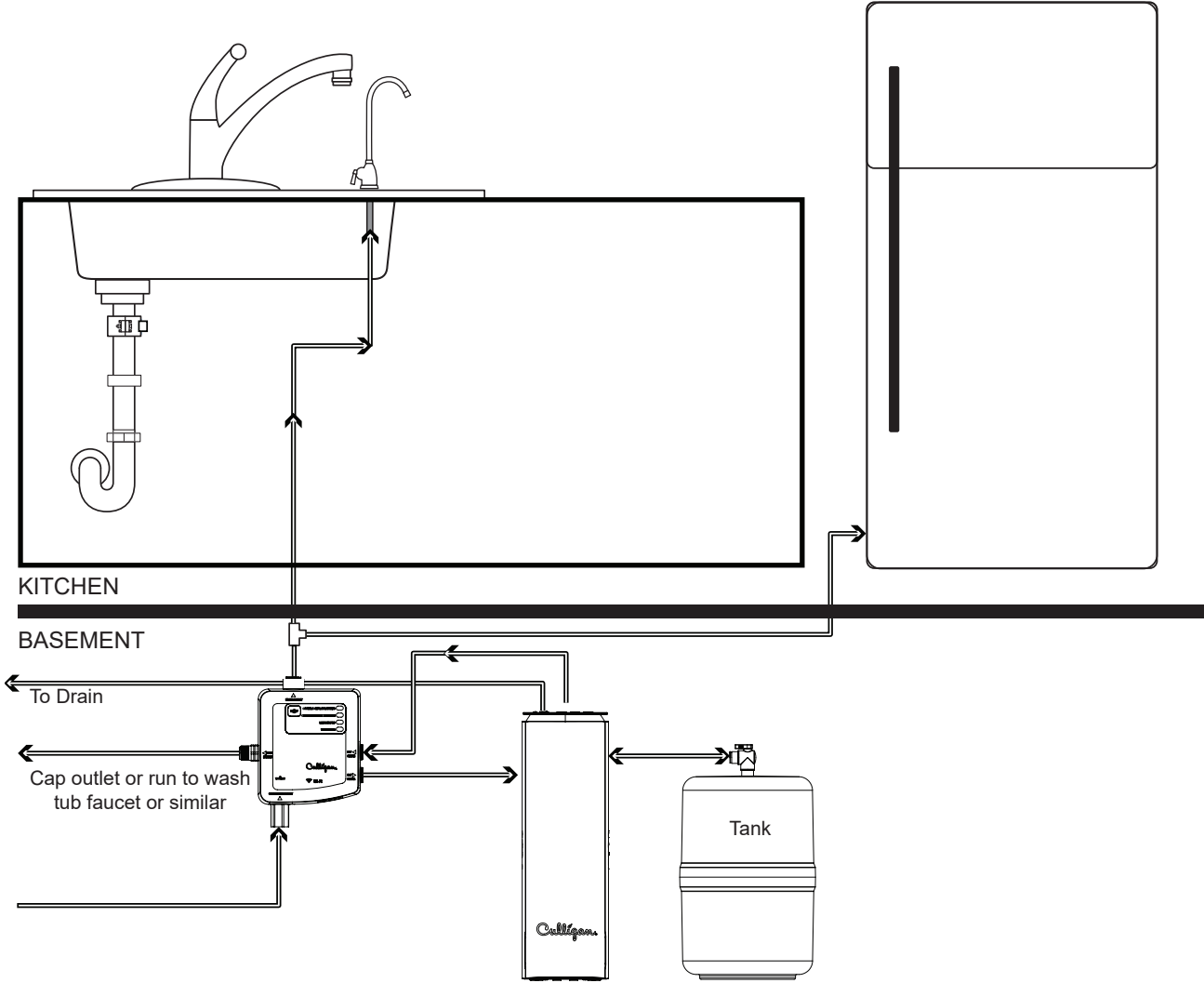

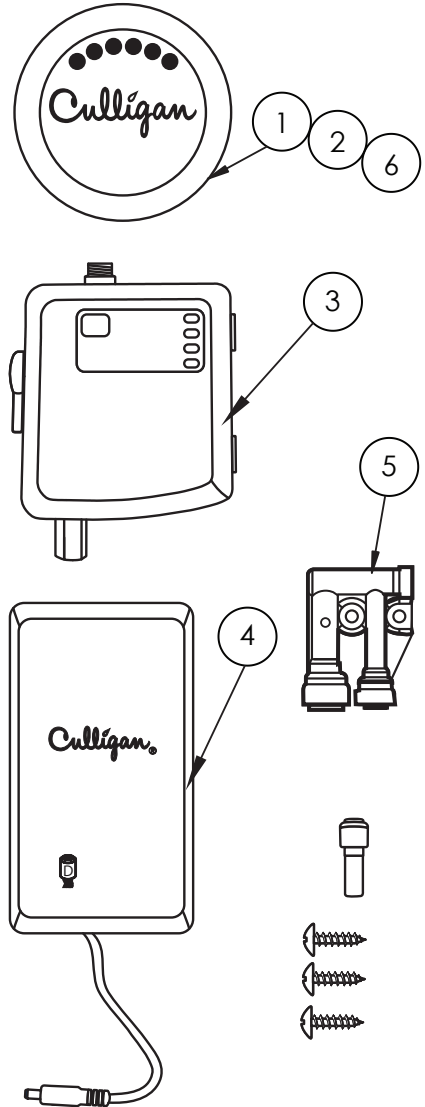
